

WHAT IS QUICKBOOKS?

✓ General

- Extremely popular accounting software (Intuit) Inc.); good for solo practitioners / small law firms
- Competition not worth mentioning (but exists)
- CPAs & bookkeepers are trained on QuickBooks
- Free 30-day trials; easy upgrades; setup wizard
- Send QuickBooks file to CPA during tax season
- Monthly subscription fee or purchase
- Bank reconciliations, credit card reconciliations, other transactions, categorize income and expenses, create invoices, work in progress, client management, reminders, financial statements, A/R, A/P, pay bills, print checks, budgeting, taxes, bank imports, etc.



QUICKBOOKS DESKTOP

- "Traditional QuickBooks" (also called <u>QuickBooks</u> <u>Desktop</u>)
- Good for solo practitioners / small law firms
- Some versions require a server
- 3 products (Pro 2020, Pro Plus 2020 & Enterprise) more features & more expensive product names change constantly
- Considerations: features, # users, data storage, access, type of business, data backup
- Must purchase additional licenses for simultaneous access (multiple users)
- Purchase, download, activate, install & setup
- Numerous optional modules, e.g., payroll, credit card processing, online backup, mobile time tracking, etc.



WHAT IS QUICKBOOKS ONLINE?

✓ General

- Online version of QuickBooks
- Access QuickBooks with secure net access & browser
- Compatible with Windows & Mac (web access)
- Free mobile app (cell phone, tablet, etc.)
- No software downloads; no software upgrades required
- Data stored in the Cloud
- Subscription based service (monthly fee)
- 5 products (Simple Start, Essentials, Plus, Advanced & Self-Employed) – more features & more expensive

✓ QuickBooks Online (QBO) vs. QuickBooks

- QBO is subscription based; no computer or server required
- QBO is fully mobile (cell, tablet, laptop, etc.)
- QBO includes secure Cloud storage (your data)
- QBO offers fastest setup & simple interface





FEATURE COMPARISON (THE GOOD, BAD & UGLY)

QuickBooks Desktop (QD) vs. QuickBooks Online (QBO)

- ✓ Response times
 - QD: Very fast response times
 - QBO: Response times dependent on net access
- ✓ Price
 - QD: Costly purchase price (\$300-\$849)
 - QBO: Affordable monthly fee (\$1 \$45)
- ✓ Upgrades
 - QD: Fixes & patches included, no upgrades
 - QBO: All upgrades included
- ✓ Customization
 - QD: Highly customizable
 - QBO: Limited customization
- ✓ Setup
 - QD: Purchase, download, install, register & setup
 - QBO: Purchase, register & setup

SETUP, COMPATIBILITY & OTHER CONSIDERATIONS

✓ Setup

- QuickBooks Online requires no download but must setup your books
- QuickBooks Desktop requires download, install, activation & must setup your books
- All versions have a setup wizard by common business types (chooses Chart of Accounts, which you can modify)
- Server versions will require IT support; Desktop versions are easy install
- Ensure your backups are scheduled & tested from day one
- Install updates & patches automatically for QuickBooks Desktop

✓ Compatibility

- Come tax time, send your firm's QuickBooks data (your company file) to your CPA & they have full access
- Many software vendors design their programs with QuickBooks integration & compatibility, e.g., Clio & MyCase send data to QuickBooks
- QuickBooks can export your firm's data (e.g., financial reports) into Excel, .csv, PDF, etc.) – all the standard file formats – you can then print or manipulate the data
- Easily convert QuickBooks Online data to QuickBooks Desktop (& vice-versa)

✓ Other considerations

- QuickBooks Desktop is a memory hog 12/16 GB RAM suggested for those computers
- A server is required for multiple simultaneous users on QuickBooks Desktop
- Intuit steers users to their Cloud storage service (online backup) but NOT required
- Intuit constantly offers complementary products & services (you still have choice)





SECURITY, REMOTE ACCESS & BACKUP

✓ Security

- Control user access to QuickBooks (Desktop or Online)
- Password protect your company file (your firm's data)
- Restrict access for certain users (protect data, prevent accidents & control confidentiality)
- QuickBooks Desktop / Server control access to storage device
- Ensure mobile users password protect their mobile devices
- Staff terminations / issues revoke access to QuickBooks
- Each QuickBooks user needs individual login & password

✓ Remote Access


- CPA / Bookkeeper might request remote access
- Remote access to server or computer might compromise data
- Remote access Desktop version of QuickBooks on work computer
- Mobile apps allow remote access (secure connection required!)

✓ Backup

- QuickBooks data is mission critical & must be backed up
- Daily / weekly backups are recommended
- Store off site full copy of firm's QuickBooks data
- Save data locally, on external hard drive & in the Cloud
- With your data (company file), you will survive any catastrophe

CPA & BOOKKEEPERS

- ✓ All CPAs & Bookkeepers should be proficient or better on QuickBooks
- ✓ Certified QuickBooks ProAdvisors (Bookkeepers & even CPAs)
- ✓ Most CPAs & Bookkeepers do NOT like QuickBooks Online, but that is okay ...
- ✓ QuickBooks Online is less powerful, less customizable & slower, but still great for small law firms / solo practitioners
- ✓ Ensure your accounting team has experience with your firm's version of QuickBooks
